महोदय/Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 28,10,400/- (Rupees Twenty Eight Lakh Ten Thousand and Four Hundred only)**, which is 60% of **total approved amount - Rs. 46,84,000/-** as Grants -in-Aid to State Government of Rajasthan for establishment of Model Career Centers (MCCs) at Jhalwar Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2- The release of grants-in-aid **Rs. 28,10,400/- (Rupees Twenty Eight Lakh Ten Thousand and Four Hundred only)** to **State Government of Rajasthan** is subject to the following terms and conditions:

- I. **State Government of Rajasthan** shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Rajasthan** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Rajasthan**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the State Government of Rajasthan as per GFR.
- VI. The State Government of Rajasthan is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2019-20 as mentioned below:
