  - II. State Government of Andhra Pradeshshall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Andhra Pradesh, shall abide by the instructions contained in the Scheme and Guidelines and ordersissued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Andhra Pradesh.
- VI. The State Government of Andhra Pradesh is requested to utilize the said amount as first installment
- VII. MOU between DGE&T and the State Government of Andhra Pradesh will need to be signed.

The expenditure involved is debatable to major head3601 Mission Mode Project Centrally Sponsored Scheme, "3601"- Labour& Employment for the year 2014-15 and major heads as mentioned below:
