The release of grants-in-aid **Rs.1,20,00,000/- (Rupees One Crore and Twenty Lakhs only)** to **State Government of Andhra Pradesh** is subject to the following terms and conditions:

- I. **State Government of Andhra Pradesh** shall strictly follow the guideline issued vide by DGE on **16th March, 2022** and other orders issued by DGE from time to time.
- II. **State Government of Andhra Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Andhra Pradesh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.


- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the State Government of Andhra Pradesh as per GFR.
- VI. The State Government of Andhra Pradesh is requested to utilize the said amount as first installment.

The amount of **Rs.1,20,00,000/- (Rupees One Crore and Twenty Lakhs only)** may be transferred to **State Government of Andhra Pradesh** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Andhra Pradesh may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO of the concerned District Employment Exchanges/UEIGB, Andhra Pradesh vide OM F. No. 1(13) PFMS/FCD/2020 dated 23rd March, 2021.
