Subject: Grants –in-Aid to **Government of Odisha**, for establishment of Model Career Centers (MCCs) at the Employment Exchange Cuttack, under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2018-2019 reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 5,59,600/- (Rupees Five Lakh Fifty Nine Thousand and Six Hundred only)** as 2nd Installment which is 20% of total approved amount – **Rs 27,98,000/-/-** as **Grant –in-Aid** to Government of Odisha, for establishment of Model Career Centers (MCCs) at the Employment Exchange Cuttack under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2018-2019.

2. The release of grant-in-aid **Rs. 5,59,600/- (Rupees Five Lakh Fifty Nine Thousand and Six Hundred only)** to **Government of Odisha** is subject to the following terms and conditions:

- I. **Government of Odisha** shall strictly follow the guideline issued by DGE on 10th Dec. 2014 and other orders issued by DGE from time to time.
- II. **Government of Odisha** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of Odisha** shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
 - I. The next installment of the fund would be released on the basis of actual expenditure incurred as per scheme guidelines, project outcome and utilization certificate furnished by the Government of Odisha as per GFR.
 - II. The Government of Odisha is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2018-2019 (Plan) and Sub heads/ Minor heads 3601.06.796.20.01.31.

The Government of Odisha may kindly transfer the amount to Office I/C, District Employment officer/ Deputy Director, Employment Exchange, Cuttack.
