 - State Government of Gujaratshallstrictly follow the guideline issued vide byDGET on 10thDec.2014and
 - State Government of Gujaratshall maintain proper accounts for purchases of IT Infrastructure, other orders issued by DGE&T from time to time. Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the 11.
 - State Government of Gujarat, shall abide by the instructions contained in the Scheme and Guidelines 111.
 - Utilization certificate issued toDGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization. 1V.
 - The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Gujarat. V.
 - The State Government of Gujarat is requested to utilize the said amount as first installment
 - MOU between DGE&T and the State Government of Gujarat will need to be signed. VI. VII.
