Subject: Grants –in-Aid to **State Government of Assam**, for establishment of Model Career Centers (MCCs) at the **Haflong Employment Exchange** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2016-2017 reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 23,91,000/- (Rupees Twenty Three Lakh Ninety One Thousand only)**, which is 60% of **total approved amount - Rs. 39,85,000 /-** as Grants –in-Aid to State Government of Assam, for establishment of Model Career Centers (MCCs) at the **Haflong Employment Exchanges** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2016-2017.

2- The release of grant-in-aid **Rs. 23,91,000/- (Rupees Twenty Three Lakh Ninety One Thousand only)** to **State Government of Assam** is subject to the following terms and conditions:

- I. **State Government of Assam** shall strictly follow the guideline issued vide by DGET on 10th Dec. 2014 and other orders issued by DGE&T from time to time.
- II. **State Government of Assam** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Assam**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Assam.
- VI. The State Government of Assam is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2016-17 as mentioned below:



The amount of Rs. 23,91,000/- (Rupees Twenty Three Lakh Ninety One Thousand only) may be transferred to State Government of Assam through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Assam, may kindly transfer the amount to District Employment Officer, Employment Exchanges, Haflong, Assam.

This issues with the concurrence of IFD M/o Labour & Employment vide their DyNo.FTS/65129/ JS & FA (L&E) dated 23-06-2016.


