Subject: Grants –in-Aid to **State Government of Uttar Pradesh**, for establishment of Model Career Centers (MCCs) at the **University Employment Information and Guidance Bureau, Bundelkhand University, Jhansi** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during **2017-2018** reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 4,12,900/- (Rupees Four Lakh Twelve Thousand and Nine Hundred only)** as 2nd Installment which is 20% of total approved amount – **Rs 20,64,500/-** as Grant –in-Aid to State Government of Uttar Pradesh, for establishment of Model Career Centers (MCCs) at the **University Employment Information and Counselling Centre, Bundelkhand University, Jhansi** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2017-2018.

2- The release of grant-in-aid **Rs. 4,12,900/- (Rupees Four Lakh Twelve Thousand and Nine Hundred only)** to **State Government of Uttar Pradesh** is subject to the following terms and conditions:

- I. **State Government of Uttar Pradesh** shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Uttar Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Uttar Pradesh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred scheme guidelines and utilization certificate furnished by the State Government of Uttar Pradesh.
- VI. The State Government of Uttar Pradesh is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2017-2018 (Plan) and Sub heads/ Minor heads 3601.06.796.20.01.31.


