- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Uttar Pradesh.
- VI. The State Government of Uttar Pradesh is requested to utilize the said amount as first installment
- VII. MOU between DGE&T and the State Government of Uttar Pradesh will need to be signed.
