  - 1. State Government of Meghalaya shall strictly follow the guideline issued by DGE on 10<sup>th</sup>Dec.2014 and other orders issued by DGE from time to time.
  - II. State Government of Meghalaya shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Meghalaya, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12Cin duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Meghalaya.

VI. The State Government of Meghalaya is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2017-18 (Plan) and Sub heads/ Minor heads .06.796.20.01.31.
