- IV. Utilization certificate issued to DGE in form GFR 12A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. NIELIT Calicut is requested to utilize the said amount as third and final installment.

The expenditure involved is debitable to Major Head "2230" - Labour & Employment for the year 2021-22 (Plan) and Sub heads/ Minor heads .02.101.10.01.31.

The grants – in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) – B/68 dated 25th November 1969.
