Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 8,19,300/- (Rupees Eight Lakh Nineteen Thousand and Three Hundred only)** as 2nd Installment which is 20% of total approved amount – Rs 4096500/- as Grants –in-Aid to NIELIT Imphal, for establishment of Model Career Centers (MCCs) at the NIELIT Imphal under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017.

2- The release of grant-in-aid **Rs. 8,19,300/- (Rupees Eight Lakh Nineteen Thousand and Three Hundred only)** to NIELIT Imphal is subject to the following terms and conditions:

- I. NIELIT Imphal shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. NIELIT Imphal shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. NIELIT Imphal, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the NIELIT Imphal.
- VI. NIELIT Imphal is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "2230" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .02.101.03.07.31.

The grants – in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) – B/68 dated 25th November 1969. 
