I am directed to convey the sanction of the President of India for release of **Rs. 1,73,54,100/- (Rupees One Crore Seventy Three Lakh Fifty Four Thousand and one Hundred only)** which is 60% of total approved amount - **Rs 2,89,23,500/-** as **Grant -in-Aid** to Government of Odisha, for establishment of Model Career Centers (MCCs) approved under National Career Service Project during 2021-22 as detailed below:-

2. The release of grant-in-aid **Rs. 1,73,54,100/- (Rupees One Crore Seventy Three Lakh Fifty Four Thousand and one Hundred only)** to **Government of Odisha** is subject to the following terms and conditions:

- I. **Government of Odisha** shall strictly follow the guideline issued by DGE on **16th March, 2022** and other orders issued by DGE from time to time.

- II. **Government of Odisha shall** maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of Odisha shall** abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred as per scheme guidelines, project outcome and utilization certificate furnished by the Government of Odisha as per GFR.
- VI. The Government of Odisha is requested to utilize the said amount as first installment.

The amount of **Rs. 1,73,54,100/- (Rupees One Crore Seventy Three Lakh Fifty Four Thousand and one Hundred only)** may be transferred to **Government of Odisha** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Odisha may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO of the concerned District Employment Exchanges, Odisha vide OM F. No. 1(13) PFMS/FCD/2020 dated 23rd March, 2021.
