I am directed to convey the sanction of the President of India for release of **Rs. 45,39,000/- (Rupees Fourty Five Lakh and Thirty Nine Thousand only)** which is 60% of **total approved amount Rs. 75,65,000/-** as Grants-in-Aid to Government of Punjab for establishment of Model Career Centers (MCCs) under National Career Service Project during 2021-22 as detailed under:-

2. The release of grants-in-aid **Rs. 45,39,000/- (Rupees Fourty Five Lakh and Thirty Nine Thousand only)** to **Government of Punjab** is subject to the following terms and conditions:

- I. **Government of Punjab** shall strictly follow the guideline issued by DGE on **16<sup>th</sup> March, 2022** and other orders issued by DGE from time to time.
- II. **Government of Punjab** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of Punjab**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.


- IV. Utilization certificate issued to DGE in form GFR 120 in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the Government of Punjab as per GFR.
- VI. The Government of Punjab is requested to utilize the said amount as first installment.

The amount of **Rs. 45,39,000/- (Rupees Fourty Five Lakh and Thirty Nine Thousand only)** may be transferred to **Government of Punjab** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Punjab may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO of the concerned District Bureau of Employment Generation & Training, Punjab vide OM F, No. 1(13) PFMS/FCD/2020 dated 23<sup>rd</sup> March, 2021.
