- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred scheme guidelines and utilization certificate furnished by the State Government of Sikkim.
- VI. The State Government of Sikkim is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2017-2018 (Plan) and Sub heads/ Minor heads 3601.06.796.20.01.31.
