Sir,

I am directed to convey the sanction of the President of India for release of Rs. 5,55,906/- (Rupees Five Lakh Fifty Five Thousand Nine Hundred and six only) as 2<sup>nd</sup> Installment which is 20% of total approved amount – Rs 27,79,532/-/- as Grant –in-Aid to State Government of Sikkim, for establishment of Model Career Centers (MCCs) at the Jorethang, State Institute of Capacity Building under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2018-2019.

- The release of grant-in-aid Rs. 5, 55,906/- (Rupees Five Lakh Fifty Five Thousand Nine Hundred and six only) to State Government of Sikkim is subject to the following terms and conditions:
  - I. State Government of Sikkim shall strictly follow the guideline issued by DGE on 10<sup>th</sup>Dec.2014 and other orders issued by DGE from time to time.
  - II. State Government of Sikkim shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc. in accordance with the Governments norms.
  - III. **State Government of Sikkim,** shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
  - IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
  - V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred scheme guidelines and utilization certificate furnished by the State Government of Sikkim.
  - VI. The State Government of Sikkim is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" — Labour & Employment for the year 2017-2018 (Plan) and Sub heads/ Minor heads 3601.06.796.20.01.31.
