Sir,

I am directed to convey the sanction of the President of India for release of Rs.28,54,200/- (Rupees Twenty Eight Lakh Fifty Four Thousand and Two Hundred only) , as Grant –in-Aid to State Government of Odisha, for establishment of Model Career Centers (MCCs) at the District Employment Office, Government ITI campus, Sambhalpur under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2014-2015

2- The release of grant-in-aid of Rs.28,54,200/- (Rupees Twenty Eight Lakh Fifty Four Thousand and Two Hundred only) to **State Government of Odisha** is subject to the following terms and conditions.

- i. **State Government of Odisha** shall strictly follow the guideline issued vide by DGET on 10th Dec. 2014 and other orders issued by DGE&T from time to time.
- ii. **State Government of Odisha** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- iii. **State Government of Odisha**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- iv. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- v. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Odisha.
- vi. The State Government of Odisha is requested to utilize the said amount as first installment
- vii. MOU between DGE&T and the State Government of Odisha will need to be signed.
