I am directed to convey the sanction of the President of India for release of Rs. 5,91,900/- (Rupees Five Lakh Ninety One Thousand and Nine Hundred only) as 2<sup>nd</sup> Installment which is 20% of total approved amount – Rs 29,59,500/-/- as Grants –in-Aid to Government of Telangana, for establishment of Model Career Centers (MCCs) at the Employment Exchange Hyderabad, Cl & T under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2019-2020.

- 2. The release of grant-in-aid Rs. 5,91,900/- (Rupees Five Lakh Ninety One Thousand and Nine Hundred only) to Government of Telangana is subject to the following terms and conditions:
  - Government of Telangana shall strictly follow the guideline issued by DGE on 10<sup>th</sup>Dec.2014 and other orders issued by DGE from time to time.
  - II. Government of Telangana shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
  - III. Government of Telangana shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
  - IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
  - V. The next installment of the fund would be released on the basis of actual expenditure incurred as per scheme guidelines, project outcome and utilization certificate furnished by the Government of Telangana as per GFR.
  - VI. The Government of Telangana is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2019-2020 (Plan) and Sub heads/ Minor heads –
