Subject: Grants –in-Aid to **State Government of Tripura**, for establishment of Model Career Centers (MCCs) at the **Agartala Employment Exchange** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2016-2017 reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 2,33,772/- (Rupees Two Lakh Thirty Three Thousand Seven Hundred and Seventy Two only)**, which is additional fund apart from total approved amount Rs. 38,48,350/- as **Grants –in-Aid to State Government of Tripura**, for establishment of Model Career Centers (MCCs) at the **Agartala Employment Exchanges** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2016-2017.

2- The release of grant-in-aid **Rs. 2,33,772/- (Rupees Two Lakh Thirty Three Thousand Seven Hundred and Seventy Two only)** to **State Government of Tripura** is subject to the following terms and conditions:

- I. **State Government of Tripura** shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Tripura** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Tripura**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Tripura.
- VI. The State Government of Tripura is requested to utilize the said amount as additional fund.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .04.789.59.01.31.

The amount of Rs. 2,33,772/- (Rupees Two Lakh Thirty Three Thousand Seven Hundred and Seventy Two only) may be transferred to State Government of Tripura through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Tripura, may kindly transfer the amount to District Employment Officer, Employment Exchanges, Agartala, Tripura.

Certified that no Utilization Certificate is pending in respect of the State mentioned in the Sanction Order as per requirement as this is additional fund.
