 - V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred scheme guidelines and utilization certificate furnished by the State Government of Uttarakhand.
 - VI. The State Government of Uttarakhand is requested to utilize the said amount as second installment.
