I am directed to convey the sanction of the President of India for release of Rs.20,21,536/-(Rupees Twenty Lakh Twenty One Thousand and Five Hundred and Thirty Six only) , as Grant –in-Aid to State Government of Tamil Nadu, for establishment of Model Career Centers (MCCs) at the District Employment Office, Government ITI campus, Vellore under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2014-2015

2- The release of grant-in-aid of Rs.20,21,536/-(Rupees Twenty Lakh Twenty One Thousand and Five Hundred and Thirty Six only) to State Government of Tamil Nadu is subject to the following terms and conditions.

- I. State Government of Tamil Nadu shall strictly follow the guideline issued vide by DGET on 10<sup>th</sup> Dec. 2014 and other orders issued by DGE&T from time to time.
- II. State Government of Tamil Nadu shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Tamil Nadu, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Tamil Nadu.
- VI. The State Government of Tamil Nadu is requested to utilize the said amount as first installment
- VII. MOU between DGE&T and the State Government of Tamil Nadu will need to be signed.

The Government of Tamil Nadu may kindly transfer the amount to Assistant Director, District Employment Office, Government ITI campus, Vellore, Tamil Nadu.
