Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 3, 03,400/- (Rupees Three Lakhs Three Thousand Four Hundred only)** as 2nd Installment which is 20% of total approved amount – **Rs 15, 17,000/-** as **Grant –in-Aid** to NIELIT, for establishment of Model Career Centers (MCCs) at the Rashtriya Sanskrit Vidyapeetha, Tirupati under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2018-2019.

2. The release of grant-in-aid **Rs. 3, 03,400/- (Rupees Three Lakhs Three Thousand Four Hundred only)** to **Rashtriya Sanskrit Vidyapeetha, Tirupati** is subject to the following terms and conditions:

- I. **Rashtriya Sanskrit Vidyapeetha, Tirupati** shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. **Rashtriya Sanskrit Vidyapeetha, Tirupati** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc., in accordance with the Governments norms.
- III. **Rashtriya Sanskrit Vidyapeetha, Tirupati** shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred scheme guidelines and utilization certificate furnished by **Rashtriya Sanskrit Vidyapeetha, Tirupati**.
- VI. The **Rashtriya Sanskrit Vidyapeetha, Tirupati** is requested to utilize the said amount as second installment and for Non-Recurring Purpose only.

The expenditure involved is debitable to Major Head "2230" – Labour & Employment for the year 2018-2019 (Plan) and Sub heads/ Minor heads 2230.02.101.10.01.31.


