2- The release of grants-in-aid Rs. **3,32,800/- (Rs. Three Lakh Thirty Two Thousand and Eight Hundred only)** to State Government of Gujarat is subject to the following terms and conditions:

- I. **State Government of Gujarat** shall strictly follow the guideline issued by DGE on 10<sup>th</sup>Dec.2014 and other orders issued by DGE from time to time.
- II. **State Government of Gujarat** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Gujarat**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of **Gujarat**.
- VI. The State Government of Gujarat is requested to make expenditure on IT Infrastructure on priority basis as per the motive of the project to transformation of the National Employment Service to provide

a variety of employment related services like job matching, career counselling, and vocational guidance to job seekers.

VII. The State Government of Gujarat is requested to utilize the said amount as second installment.


The expenditure involved is debit to Major Head "3601" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .03.331.01.01.31.

The amount of **Rs. 3,32,800/- (Rs. Three Lakh Thirty Two Thousand and Eight Hundred only)** may be transferred to **State Government of Gujarat** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Gujarat, may kindly transfer the amount to **District Employment Officer, Employment Exchanges, Surat, Gujarat.**
