Subject: Transfer of funds/Grants in Aid to EPFO vide Assignment Mode under TSA for Employer's Contribution under Aatmanirbhar Bharat Rojgar Yojana (ABRY)-regarding

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 175.00 Crore (Rupees One Hundred and Seventy Five Crore only) (NER)** for contribution crediting for a period of two years both the employees' share (12% of wages) and employers share' (12% of wages) of contribution payable or only the employees' share, depending on employment strength of the EPFO registered establishments to EPFO during the Year 2022-23.

- 2. The release of grants in aid of **Rs. 175.00 Crore (Rupees One Hundred and Seventy Five Crore only) (NER)** to Employees Provident Fund Organisation (EPFO) is subject to the following conditions:
  - i) Scheme shall be implemented by EPFO strictly as per the announcement by the Ministry of Labour & Employment in this regard. EPFO shall be solely responsible for any deviation in the selection of beneficiary establishment/employee.
  - ii) Guidelines of the scheme should be followed strictly.
  - iii) EPFO shall develop software for implementing the scheme and also develop a procedure which is transparent and accountable at their end.
  - iv) EPFO shall put in place a mechanism to monitor the implementation of the Scheme and provide Analytic Monthly Reports and Weekly Status Report to the Ministry/DGE for effective monitoring of the scheme.
  - v) Fund shall be utilised for the purpose for which it is sanctioned. Subsequent instalments may be released on the basis of previous achievements.
  - vi) Third party evaluation will also be undertaken on a periodic basis and report may be forwarded to Directorate General of Employment, Ministry of Labour and Employment.

- vii) Utilization Certificate along with audited statements of accounts should be furnished to the Ministry of Labour & Employment, Government of India, as per General Financial Rules, 2017.
- 3. The expenditure involved in the ABRY scheme is debitable to the Major Head "2230" Labour Employment and Skill Development, "01" Labour, "111" Social Security for Labour "06" Social Security Schemes, "08" Aatmanirbhar Bharat Rojgar Yojana (ABRY), "31" Grant-in-Aid General under Aatmanirbhar Bharat Rojgar Yojana (ABRY) **or** "North eastern Area", "00" Labour, "473" Social Security for Labour, "06" Social Security Schemes, "10" Aatmanirbhar Bharat Rojgar Yojana (ABRY), "31" Grant-in-Aid General under Aatmanirbhar Bharat Rojgar Yojana (ABRY) for the year 2022-23.
- 4. The amount Rs. 175.00 Crore (Rupees One Hundred and Seventy Five Crore only) (NER) may be transferred to EPFO vide Assignment mode under TSA as per Bank Account details given below:

The accounts of grantee Institution shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the institution or Organization is called upon to do so.
