Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 16,75,500/- (Rupees Sixteen Lakh Seventy Five Thousand and Five Hundred only)**, which is 60% of total approved amount - **Rs. 27,92,500/-** as Grants –in-Aid to State Government of **Himachal Pradesh**, for establishment of Model Career Center (MCCs) at the **Shimla Employment Exchanges** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2015-2016.

2-The release of grant-in-aid **Rs. 16,75,500/- (Rupees Sixteen Lakh Seventy Five Thousand and Five Hundred only)**, to **State Government of Himachal Pradesh** is subject to the following terms and conditions:

- I. **State Government of Himachal Pradesh** shall strictly follow the guideline issued vide by DGET on 10<sup>th</sup> Dec. 2014 and other orders issued by DGE&T from time to time.
- II. **State Government of Himachal Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Himachal Pradesh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of **Himachal Pradesh**.
- VI. The **State Government of Himachal Pradesh** is requested to utilize the said amount as first installment.

The expenditure involved is debit to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:

The Government of **Himachal Pradesh**, may kindly transfer the amount to Regional Employment Officer, Employment Exchanges, **Shimla, Himachal Pradesh**.
