- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the State Government of Arunachal Pradesh as per GFR.
- VI. The State Government of Arunachal Pradesh is requested to utilize the said amount as first installment.
