I am directed to convey the sanction of the President of India for release of Rs. 1,06,27,200/- (One Crore Six Lakh Twenty Seven Thousand and Two Hundred Only), which is 60% of total approved amount - Rs. 1,77,12,000/- as Grants -in-Aid to State Government of Telangana for establishment of Model Career Centers (MCCs) approved under National Career Service Project during 2021-22 as detailed below:-

The release of grants-in-aid Rs. 1,06,27,200/- (One Crore Six Lakh Twenty Seven Thousand and Two Hundred Only), to State Government of Telangana is subject to the following terms and conditions:

- I. State Government of Telangana shall strictly follow the guideline issued vide by DGE on 16th March 2022 and other orders issued by DGE from time to time.
- II. State Government of Telangana shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Telangana, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.


- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the State Government of Telangana as per GFR.
- VI. The State Government of Telangana is requested to utilize the said amount as first installment.

The amount of **Rs. 1,06,27,200/- (One Crore Six Lakh Twenty Seven Thousand and Two Hundred Only)**, may be transferred to **State Government of Telangana** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Telangana may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO of the concerned District Employment Exchanges, Telangana vide OM F. No. 1(13) PFMS/FCD/2020 dated 23rd March, 2021.
