महोदय/Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 22, 93,920/- (Rupees Twenty Two Lakh Ninety Three Thousand Nine Hundred and Twenty only)**, which is 60% of **total approved amount - Rs. 38,23,700/-** as Grants -in-Aid to State Government of Uttarakhand for establishment of Model Career Centers (MCCs) at the Almora Employment Exchanges under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2018-2019.

2- The release of grants-in-aid **Rs. 22, 93,920/- (Rupees Twenty Two Lakh Ninety Three Thousand Nine Hundred and Twenty only)** to **State Government of Uttarakhand** is subject to the following terms and conditions:

- I. **State Government of Uttarakhand** shall strictly follow the guideline issued vide by DGE on **10<sup>th</sup> Dec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Uttarakhand** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Uttarakhand**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred, Project outcome and utilization certificate furnished by the State Government of Uttarakhand as per GFR.
- VI. The State Government of Uttarakhand is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2018-19 as mentioned below:

The Government of Uttarakhand may kindly transfer the amount to Deputy/Assistant Director/District Employment Officer/DDO, Employment Exchanges, Almora, Uttarakhand.
