Sir,  
 In continuation to the earlier order of even No. dated 01-06-2015, I am directed to convey the sanction of the President of India for release of Rs. 40,000 (Rupees Forty Thousand Only), as remaining amount of the first installment [60% of total approved amount i.e. Rs. 9, 97, 950 (Rupees Nine Lakh Ninety Seven Thousand And Fifty Only) less the part payment of Rs. 9, 57, 997 (Rupees Nine Lakh Fifty Seven Thousand Nine Hundred Ninety Seven)] as Grant -in-Aid to MCC Centurion University of Technology & Management, for establishment of Model Career Center (MCC) at Centurion University of Technology & Management, Paralakhemundi, Odisha under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-2016.  
 2- The release of grant-in-aid Rs. 40,000 (Rupees Forty Thousand Only) to MCC Centurion University of Technology & Management, for establishment of Model Career Centers (MCCs) at the Paralakhemundi, Odisha is subject to the following terms and conditions.

- I. The MCC, Centurion University of Technology & Management, for establishment of Model Career Centers (MCCs) at Paralakhemundi, Odisha shall strictly follow the guidelines issued vide by DGET on 10<sup>th</sup> Dec. 2014 and additional guidelines for other than Central/State Governments Institutions issued on 05.03.2015.
- II. The MCC, Centurion University of Technology & Management, for establishment of Model Career Centers (MCCs) at Paralakhemundi, Odisha shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc related to the MCC, in accordance with the Governments norms.
- III. The MCC, Centurion University of Technology & Management, for establishment of Model Career Centers (MCCs) at Paralakhemundi, Odisha shall abide by the instructions contained in the Scheme and Guidelines and orders issued by DGET from time to time.
- IV. The MCC, Centurion University of Technology & Management, for establishment of Model Career Centers (MCCs) at Paralakhemundi, Odisha shall strictly follow all the provisions and rules contained in chapter 09 under 'GIA and Loans' of GFR-2005.
- V. The MCC, Centurion University of Technology & Management, Paralakhemundi, Odisha is requested to utilize the said amount as first installment.
- VI. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VII. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the MCC Centurion University of Technology & Management.
- VIII. The MCC, Centurion University of Technology & Management shall utilize the above Grants-in-Aid for Non Recurring purposes only.
- IX. Noted at serial No. 1 in Register of Grants.
- X. The above amount as Grants-in-Aid shall be spent in the Financial Year 2015-16 and in any condition not later than March 31, 2016.
- XI. The Agreement between DGE&T and the Centurion University of Technology & Management has been signed.
- XII. This sanction issues with the approval of the Secretary, Ministry of Labour and Employment in consultation with the Integrated Finance Division of the Ministry.


