Sir,

I am directed to convey the sanction of the President of India for release of Rs. 15, 40, 560 (Rupees Fifteen Lakh Forty Thousand Five Hundred And Sixty Only), as the 60% of the total approved amount (Rs 25, 67,600/-) as Grant -in-Aid to MCC Don Bosco Tech Society, for establishment of Model Career Center (MCC) Don Bosco Tech Society, Bangalore, Karnataka under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-2016.

2- The release of grant-in-aid Rs. 15, 40, 560 (Rupees Fifteen Lakh Forty Thousand Five Hundred And Sixty Only) to MCC Don Bosco Tech Society, Bangalore is subject to the following terms and conditions.

- I. The MCC, Don Bosco Tech Society, Bangalore shall strictly follow the guidelines issued vide by DGET on 10th Dec. 2014 and additional guidelines for other than Central/State Governments Institutions issued on 05.03.2015.
- II. The MCC, Don Bosco Tech Society, Bangalore shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, related to the MCC in accordance with the Governments norms.
- III. The MCC, Don Bosco Tech Society, Bangalore, shall abide by the instructions contained in the Scheme and Guidelines and orders issued by DGET from time to time.
- IV. The MCC, Don Bosco Tech Society, Bangalore shall strictly follow all the provisions and rules contain in chapter 09 under "GIA and Loans" of GFR-2005.
- V. The MCC, Don Bosco Tech Society, Bangalore is requested to utilize the said amount as first installment.
- VI. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VII. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the MCC Don Bosco Tech Society, Bangalore.
- VIII. The MCC, Don Bosco Tech Society, Bangalore shall utilize the above Grants-in-Aid for Non Recurring purposes only.
- IX. Noted at serial No. 11 in Register of Grants.
- X. The above amount as Grants-in-Aid shall be spent in the Financial Year 2015-16 and in any condition not later than March 31, 2016.
- XI. The Agreement between DGE&T and the Don Bosco Tech Society, Bangalore has been signed.
