- V. The next installment of the fund would be released as per provision of GFR on the-basis of actual expenditure incurred and utilization certificate furnished by the State Government of West Bengal.
- VI. The State Government of West Bengal is requested to utilize the said amount as first installment
- VII. MOU between DGE&T and the State Government of West Bengal will need to be signed.
