SALIENT FEATURES

1. The total number of Establishments in the Organised sector as on 31-3-93 was 262.6 thousands. Thus, there is an increase of Establishments by 1.05% over the previous year. The Public and Private sector recorded growth of 1.37% and 0.62% respectively.
2. The total employment in the Organised sector was estimated at 27176.6 thousands as on 31st March 1993. The increase in the total employment was of the order of 0.45 percent over the employment (27055.7 thousands) as on 31st March 1992.
3. The Public sector and Private sector employed 19326.1 thousands and 7850.5 thousand employees respectively. The growth of employment in the Public sector was 0.61% whereas Private sector recorded a growth of 0.06% as compared to the last year.
4. The highest increase in employment in terms of percentage, over the preceding year was observed in the North Eastern zone (1.88%) followed by Southern zone (1.08%), Western zone (0.93%), Northern zone (0.92%). Eastern zone and Central Zone, however recorded a negative growth of 1.17% and 0.21% respectively.
5. Among the States and Union Territories, West Bengal, Madhya Pradesh, Orissa and Tamil Nadu recorded a negative growth rate in terms of employment. The growth, in terms of percentage, was more than five percent in Tripura, Manipur and Nagaland.
6. Electricity, Gas and Water (div.-4) and Services sectors (Divs-8 and 9) only recorded a positive growth rate compared to last year.
7. Among the Public sector, the Employment in Quasi Government (States) recorded highest increase (2.06%). Central Government and Local Bodies however, recorded a negative growth rate of 1.33% and 1.73% respectively.
8. The number of job-seekers on the live registers of the employment exchanges in the States/UT's covered under EMI as on 31st March 1993 was 36291 thousands.

WOMEN EMPLOYMENT

9. Women employment in the organised sector as on 31st March 1993 was estimated at 4026.3 thousands, comprising about 14.8% of the total organised sector employment.
10. Out of the total women employment (4026.3 thousands), 2476.7 thousands were in the Public Sector and the remaining 1549.7 thousands were in the Private Sector.
11. The increase of women employment over the last year was of the order of 3.03%, 1.97% in the Public Sector and 4.76% in the Private Sector.
12. The employment of women was maximum in Southern zone (1519.8 thousands) and minimum in Central zone (393.2 thousands). The increase in employment in terms of percentage was highest in Southern zone (5.43%) where as Northern Zone recorded the minimum (0.60%). The increase in women employment compared to last year was maximum in Andhra Pradesh.
13. The distribution of women employees in major Industries reveals that Community, Social & Personal Services Sector (Div 9) continued to absorb majority (56%) of the women employees. The lowest employment was noticed in Electricity, Gas & Water Sector (Div 4).

CHAPTER-I

INTRODUCTION

1.1 The present quarterly Employment Review relating to the period January-March, 1993 is based on the statistics collected under the Employment Market Information (EMI) Programme of the Directorate General of Employment & Training, Ministry of Labour, Government of India.

1.2 Under the EMI programme information is collected on the level of employment in the organised sector of the economy, which comprises all establishments in the public sector and non-agricultural establishments employing 10 or more persons in the private sector. Whereas data from all the establishments in the public sector and those non-agricultural establishments in the private sector employing 25 or more persons are obtained statutorily under the provisions of the Employment Exchanges (Compulsory Notification of Vacancies) Act, 1959, the data from non-agricultural establishments engaging 10 to 24 persons in the private sector are collected on a voluntary basis.

1.3 Collection of data under the programme is through the 'Establishment Reporting System'. All the establishments are required, at quarterly intervals, to supply details about the number of persons they are employing, vacancies occurred and the type of persons who are in short supply. The information relates only to 'Employers' and 'Employees'. The term 'Employers' means owners, proprietors, managers, working partners or directors of the firms/companies. On the other hand, 'Employees' include all those persons whose wages or salaries are paid from the establishments but does not cover part-time employee and apprentices. The EMI programme does not cover the following sectors:-

- i) Self employed or independent workers.
- ii) Agricultural and allied operations in the private sector, except for plantations which are covered on a voluntary basis.
- iii) Household establishments.
- iv) Non-agricultural establishments in the private sector employing less than 10 workers.
- v) Employment in Indian Missions/Embassies abroad, Defence forces and those not covered due to administrative reasons, and
- vi) The smaller establishments employing 10-24 persons in the private sector in the metropolitan areas of Greater Bombay and Calcutta (which are not covered due to practical difficulties).

1.4 As far as geographical coverage is concerned, the EMI Programme is in operation in all States/Union Territories of the country except Sikkim, Arunachal Pradesh, Dadar and Nagar Haveli and Lakshdweep. The programme has not been extended to these States/Union Territories so far.

1.5 The programme has the following limitations:-

- i) The frame of establishments maintained at the Employment Exchanges is not comprehensive in certain cases, and
- ii) Employment in respect of non-responding establishments had to be estimated.

1.6 The processing of the data for the present review was based on the quarterly returns received for the quarter ending 31st March 1993. However since the returns from J & K, Orissa, Pondicherry and A & N Islands were not received the data for March 92 have been considered. The data may undergo a minor change when employment at three digit level of NIC is finalised. In view of this, the data reported in the present review may be treated as provisional.

CHAPTER - II

OVER-ALL EMPLOYMENT SITUATION IN THE
ORGANISED SECTOR

ESTABLISHMENTS

The number of establishments in the organised sector which were addressed for employment data, during the quarter ended March, 1993 had gone up to 262.61 thousands. Out of these establishments, 154.42 thousands were in the Public Sector and the remaining 108.19 thousands were in the Private Sector. The number of establishments at the end of March, 1993 by branches of public sector, and size of establishments in the private sector alongwith percentage changes over corresponding quarter of the last year are presented in the following Table-I.

2.2 It will be observed from Table-I above the total number of establishments in the organised sector which was 259.9 thousands at the end of March 1992 increased to 262.6 thousands at the end of March, 1993, registering a growth of 1.1%. The growth in Public and Private sectors was 1.4% and 0.6% respectively.

2.3 Zone-wise\State wise break up of establishments and employment for the quarter under reference i.e. Jan-March, 1993 is presented in Annexure-I. The no of establishments in different States/Union Territories are given in Annexure-II.

TOTAL EMPLOYMENT

2.4 The total employment in the 'Organised Sector' of the country was estimated at 27176.6 thousands at the end of the quarter under reference (Jan-March, 1993), as compared to 27104.6 thousands, at the end of preceding quarter (Oct.-Dec.1992) showing an increase of only 0.27%. The sector wise employment for the quarters viz. January-March, 1993 and October-December, 1992 alongwith percentage changes is given in the following Table-2

2.5 It will be observed from Table-2 above that the rate of growth of employment in public and private sectors was only 0.10% and 0.67% respectively over the previous quarter. The yearly growth was not substantial and was only 0.45%, 0.61% in the Public sector and 0.06% in the Private sector.

2.6 Zone-wise\State-wise distribution of employment as on 31st March, 1993 by different branches of public sector and size of establishments in the private sectors is given in Annexure-III.

EMPLOYMENT(TOTAL) BY ZONES

2.7 The country has been divided into six Zones, according to the State Reorganisation Act, 1956. The Union Territory of Andaman & Nicobar Islands has, however, been kept outside the scheme of Zonal classification embodied in the said Act. The distribution of employment in various Zones and Union Territories of Andaman & Nicobar Islands for the quarter under review i.e. quarter ending March, 1993 as well as in the preceding quarter ending December, 1992, is shown in Table-3 below:-

2.8 It will be seen from Table-3 above that the highest increase in employment in terms of percentage, over the preceding quarter was in North eastern Zone (2.82%). Central Zone had a negative growth rate of 0.25%. The increase in employment in other Zones and in Andaman & Nicobar Islands was insignificant.

2.9 During the period March.1992 to March 1993 the increase in employment was of the order of 0.45%. The increase was 1.88% in North Eastern Zone, 0.92% in Northern Zone, 0.93% in Western Zone, 1.08% in Southern Zone, - 1.17% in Eastern Zone, and -0.21% in Central Zone. The employment in Andaman and Nicobar Island remained more or less the same.

EMPLOYMENT BY STATES \UNION TERRITORIES

2.10 The employment in various States\Union Territories during the quarter under review is given in Annexure-IV. It will be noticed there from that Tripura registered the highest increase of 8.50% in employment, over the preceding quarter followed by Assam((2.87%), Chandigarh(1.11%). The increase in employment over the previous quarter in other States was less than 1% each. The decline in employment was noticed in Haryana, Himachal Pradesh, Madhya Pradesh, Utter Pradesh, Manipur, Pondicharry, and Tamil Nadu.

EMPLOYMENT BY INDUSTRIES

2.11 Annexure-V presents employment picture by industry division. The employment in all the Industries except Electricity, Gas and Water (Div-4) and Services sectors (Div-8&9) declined compared to last year. Financing, Insurance, Real Estate & Business Services recorded a growth rate of 3.27%. Details about the Employment in States\Union Territories by Industry Divisions as on 31-3-93 are given in Annexure-VI & VII respectively for Public and Private Sectors.

CHAPTER - III

EMPLOYMENT IN PUBLIC SECTOR

3.1 Employment in the public sector had gone up from 19306.5 thousands at the end of the quarter September-December, 1992 to 19326.1 thousands at the end of the quarter Jan.,-March, 1993 registering an increase of only 0.10% The increase in employment over last year (i.e March 1992) was of the order of only 0.61%

PUBLIC SECTOR EMPLOYMENT CLASSIFIED BY BRANCH OF ESTABLISHMENTS

3.2 State-wise data on employment in the public sector by its various branches viz. Central Government, State Government, Quasi-Government(Central), Quasi-Government(State), and Local Bodies are given in Annexure-III. Branch-wise analysis of employment is provided in the following Table-4.

The employment in Quasi Govt.(S), State Govt. and Quasi Govt.(C) increased by 2.06%, 1.43% and 4.95% respectively during the year. There was decline in employment in the Central Govt. (-1.33%), and in Local Bodies (-1.73%).

PUBLIC SECTOR EMPLOYMENT BY ZONES

3.3 Zone-wise employment and its change over the previous quarter in the Public Sector are shown in Table-5 below.

North Eastern Zone recorded a rise of 1.02% in employment during a period of three months, i.e January to March 1993. other Zones recorded either a negative growth or a very little growth.

PUBLIC SECTOR EMPLOYMENT BY STATES/UNION TERRITORIES

3.4 The employment in Public Sector in all the States Except Tripura either has decreased or remained more or less static over previous quarter. The largest decrease in Public sector employment was, however, noticed in Himachal Pradesh (-0.89%). The details are given in Annexure-IV.

PUBLIC SECTOR EMPLOYMENT BY INDUSTRY.

3.5 It will be seen from Annexure-V that the highest increase of employment in the public sector in any industry division was 3.11% in Financing, Insurance, Real Estate & Business Services during the period 31st march 1992 to 31st march 1993. Negative growth has been noticed in as many as in four industry divisions namely Agriculture, Manufacturing, Trade and transport.

CHAPTER -IV

EMPLOYMENT IN PRIVATE SECTOR

4.1 The employment in the private sector had increased by only 0.67% over the previous quarter. In absolute terms, the employment in the private sector had gone up from 7798.1 thousands, at the end of December, 1992 to 7850.5 thousands, at the end of March, 1993.

EMPLOYMENT IN PRIVATE SECTOR BY SIZE GROUPS

4.2 Table-6 below gives employment in the private sector by size of establishments. It would be seen therefrom that the employment in Act establishments (employing 25 or more persons) has registered a decrease of 0.14% whereas the employment in Non-Act establishments (employing 10 to 24 persons) has increased by 1.57% over the previous year. The overall increase was insignificant (0.06%).

PRIVATE SECTOR EMPLOYMENT BY ZONES

4.3 The distribution of Private Sector employment by Zones is presented in the following Table-7. It will be observed that employment in the Private Sector recorded a nominal increase only in the North Eastern Zone (5.44%) compared to the employment recorded during the previous quarter i.e as on 31-12-92. In the other Zones the employment remained more or less static.

PRIVATE SECTOR EMPLOYMENT BY STATES/UNION TERRITORIES

4.4 The State-wise employment in the private sector (Annexure-IV) shows the highest increase over the previous quarter, by 22.72% in Tripura. Significant increase in employment has not been observed in any of the other States except in Hissachal Pradesh. Private Sector participation in Hissachal Pradesh and Tripura, however, was nominal and hence has very little effect in overall Private Sector employment.

PRIVATE SECTOR EMPLOYMENT BY INDUSTRY DIVISIONS:

4.5 During last one year considerable increase in Private Sector employment was observed in Trade, Transport, and Services Sectors only. Financing, Insurance, Real Estate & Business Services registered the maximum growth rate of 4.04%.

CHAPTER -V

WOMEN EMPLOYMENT

5.1 Women employment in the 'Organised Sector' of the economy, at the end of the quarter under Review (Jan-March, 1993), was 4026.3 thousands, comprising about 14.8% of the total organised sector employment.

Out of the total women employment (4026.3 thousands), 2476.7 thousands was in the public sector and the remaining 1549.7 thousands in the Private Sector. Sector-wise women employment had increased by 0.39% in Public Sector and 1.77% in the Private Sector over the previous quarter. There was an over all increase of 0.92% in women employment, over the previous quarter.

Women employment in Public and Private sector for the current quarter and previous quarter and the percentage change are given in Table-8 below.

5.3 Compared to the employment recorded during last quarter i.e quarter ending 31st Dec.1992 the women employment had gone down in North Zone to the extent of -0.10%. In all other Zones there was an increase .The highest was in North eastern Zone(4.98%)

WOMEN EMPLOYMENT BY STATES/UNION TERRITORIES

5.4 The details of women employment by States/Union Territories are shown in Annexure-VIII. It will be seen therefrom that women employment recorded the highest increase of 5.48% in Assam compared to the employment recorded as on 31st Dec. 1992.

WOMEN EMPLOYMENT IN DIFFERENT INDUSTRIES.

5.5. The distribution of women employees in Major Industries are shown in Annexure-IX. The distribution reveals that Community, Social & personal Services Sector (Div-9) continues to absorb majority (56%) of the Women employees. The lowest employment was noticed in Electricity, Gas & water Sector (i.e Div-4). In terms of percentage the women employment increased by 8.22% over the previous year's employment in Manufacturing Sector.

CHAPTER-VI

JOB-SEEKERS AND JOB VACANCIES

JOB SEEKERS REGISTERED WITH THE EMPLOYMENT EXCHANGES

6.1 The Employment Exchanges functioning in various states/Union Territories of the country register job-seekers who approach the Exchanges for employment assistance. The number of job-seekers on the Live Register of the Employment Exchanges in the States/U.Ts covered under E.M.I as on 31st March 1993 and as on 31st Dec.1992 stood at 36291.0 thousand and 36743.4 thousand respectively.

6.2 The total number of vacancies notified to the Employment Exchanges by employers in the Public and Private sectors during Jan.- Dec.1992 and during Jan.- March 1993 were 415.9 and 86.9 Thousand respectively.

6.3 From the above statistics (paras 6.1 and 6.2), the true picture of demand and supply in the labour market does not get reflected as all the vacancies occurring in the economy are not notified to the Employment Exchanges and registration being voluntary all unemployed persons do not get themselves registered with the Employment Exchanges.

6.5 The number of job-seekers on the Live Register of Employment Exchanges and vacancies notified to the Exchanges by States/Union Territories are given in Annexure-XII.
