## MINISTRY OF LABOUR D.G.E & T.

New Delhi, the 27th December, 1996

G.S.R. 60.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Vocational Rehabilitation Centres (Class-I and Class-II posts) Recuitment Rules, 1969, in so far as they relate to the post of Rehabilitation Officer and Psychologist, except as respects things done or omitted to be done before such supersession the President hereby makes the following rules regulating the metheod of recruitment to Group 'B' (Gazetted) posts in the offices of the Vocational Rehabilitation Centres under the Directorate General of Employment and Training, Ministry of Labour, namely:—

- 1. Short title and commencements.—(1) These rules may be called the Vocational Rehabilitation Centres (Group 'B' Gazetted Posts), Recruitment Rules, 1996.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application.—These rules shall apply to the posts specified in Column 1 of the Schedule annexed hereto.
- 3. Number, Classification and scale of pay.— The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the said Schedule.
- 4. Age limit, method of recruitment and other qualifications etc.—The age limit, qualifications, methods of recruitment and other matters relating

to the posts shall be as specified in columns 5 to 14 of the schedule aforesaid.

- 5. Disqualification.—No person,—
  - (a) who has entered into or contracted a marriage with a person having a spouse living, or
  - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax.—Where the Central Government is of opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect of any class or category of persons.
- 7. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the Scheduled Tribes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Note: Where Juniors who have completed their qualifying eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than one year and have successfully completed their probation period, if prescribed.

Transfer on deputation (including short term contract):

Officers of the Central/State Governments/ Union Territories/Autonomous Organisations:

- (a) (i) holding analogous posts on regular basis;
- (ii) with three years' regular service in posts in the scale of Rs. 1640-2900 or equivalent; or
- (iii) with eight years' regular service in posts in the scale of Rs. 1400-2300/2600 or equivalent; and
- (b) possessing the educational qualifications and experience prescribed for direct recruits under column 8.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly deputationists shall not be eligible for consideration for appointment by promotion. (Period of deputation including period of deputation in another excadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by transfer on deputation (including short-term contract) shall be, not exceeding 56 years, as on closing date of receipt of applications.)

- 1. Director of Employment Exchanges: Chairman.
- 2. Deputy Secretary (Administration) Ministry of I abour: Member.
- 3. Deputy Secretary, Directorate General of Employment and Training: Member.
- 4. Joint Director of Employment

Exchanges: Member. Note-The proceedings of the Departmental Promotion Committee relating to confirmation of a direct recruit shall be sent to the commission for approval. If however, these are not approved by the Commission a fresh meeting of the Departmental Promotion Committee to be presided over by the Chairman or a Member of the Union Public Service Commission shall be held.
