G.S.R. 145.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Vocational Rehabilitation Centres (Group 'C' and 'D' posts) Recruitment Rules, 1980 in so far as they relate to the posts of Workshop Engineer and Rehabilitation Counsellor, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rule regulating the method of recruitment to the posts of Workshop Engineer and Rehabilitation Counsellor in the offices of the Vocational Rehabilitation Centres under the Directorate General of Employment and Training, Ministry of Labour, namely:—

- 1. Short title and commencement.—(i) These rules may be called the Vocational Rehabilitation Centres (Group 'B' Non-Gazetted posts) Recruitment Rules, 1996.
- (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of the post, its classification and scale of pay.— The number of the said posts, their classification and scale of pay attached thereto shall be as specified in columns 2 to 4 of the schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications etc.-The method of recruitment, age limit, qualifications are

other matters relating to the said posts shall be as specified in columns 5 to 14 of the said schedule.

- 4. Disqualifications.-No person,
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post

- Provided that the Central Government may, if satisfied that such marriago is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or categoy of persons.
- 6. Saving.—Nothing in these rules shall affect reservation, reluxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the scheduled tirbes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government fro mtime to time in this regard.

- G.S.R, 743.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Vocational Rehabilitation Centre (Class III and IV posts) Recruitment Rules, 1970, the President hereby makes the following rules regulating the method of recruitment to Group 'C' and 'D' posts in the offices of the Vocational Rehabilitation Centres under the Directorate General of Employment and Training, Ministry of Labour, namely :-
- 1. Short title and commencement :--(i) These rules may be called the Vocational Rchabilitation Centres (Group C and D posts) Recruitment Rules, 1980.
 - (ii) They shall come into force on the date of their publication in the official Gazette
- 2. Application :- These rules shall apply to the posts specified in column 1 of the schedule annexed to these rules.
- 3. Number, classification and scales of pay:--The number of posts, their classification and the scales of pay attached thereto, shall be as specified in column 2 to 4 of the schedule aforesaid.

- 4. Age limit, Method of recruitment and other qualifications:—The age limit, qualifications, method of recruitment and other matters relating to the said posts shall be as specified in columns 5 to 13 of the said schedule



Saving:-Nothing in these rules shall affect reservations relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the Scheduled Tribes and other special categories in accordance with the orders issued by the Central Government from time to time in this regard.


