I am directed to convey the sanction of the Competent Authority for release of **Rs. 8,19,300/- (Rupees Eight Lakh Nineteen Thousand and Three Hundred only)** as 2<sup>nd</sup> Installment which is 20% of **total approved amount - Rs 40,96,500/-** as **Grants -in-Aid** to NIELIT Aurangabad, for establishment of Model Career Centers (MCCs) at the NIELIT **Aurangabad** under National Career Service Project during 2023-24 as follows: -

2. The release of grant-in-aid **Rs. 8,19,300/- (Rupees Eight Lakh Nineteen Thousand and Three Hundred only)** to NIELIT Aurangabad is subject to the following terms and conditions:

- I. NIELIT Aurangabad shall strictly follow the guideline issued by DGE on **10<sup>th</sup>Dec.2014** and other orders issued by DGE from time to time.
- II. NIELIT Aurangabad shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. NIELIT Aurangabad shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.


- IV. Utilization certificate should be issued to DGE in form GFR 12A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the NIELIT, Aurangabad.

The grants - in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) - B/68 dated 25<sup>th</sup> November 1969. The Section Officer (Cash Section)/Drawing and Disbursing officer, DGE, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para - 1 above for **Rs.8,19,300/- (Rupees Eight Lakh Nineteen Thousand and Three Hundred only)** and remit the same to NIELIT, Aurangabad for establishment of Model Career Center (MCC) at **Aurangabad**, through E-remittance under intimation to DGE, New Delhi as per details given below.
