- II. AISECT shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. AISECT shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate should be issued to DGE in form GFR 12A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. AISECT is requested to utilize the said amount as third and final installment.

The grants – in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) – B/68 dated 25<sup>th</sup> November 1969.
