

## NATIONAL CLASSIFICATION OF OCCUPATIONS

### DIVISION-X

#### WORKERS NOT CLASSIFIED BY OCCUPATIONS

Workers classified in this Division are those persons seeking employment who have not received any professional, technical or vocational training or workexperience; persons reporting occupations that can not be identified; persons reporting occupations not sufficiently described to permit classification and workers not reporting any occupation. Excluded are those persons seeking employment only in specific occupations.

#### X0 NEW WORKERS SEEKING EMPLOYMENT

Workers classified in this Sub-Division are those seeking work, who have not received professional, technical or vocational training and do not possess significant work experience or have had only incidental work experience such as casual work during school holidays or helping in family enterprise. Excluded are persons with post-graduate qualifications seeking employment in occupations according to subject in which specialised and persons seeking employment as unskilled labourers.

#### X00 NEW WORKERS SEEKING EMPLOYMENT

Workers classified in this Group are those seeking work, who have not received professional, technical or vocational training and do not possess significant work experience or have had only incidental work experience such as casual work during school holidays or helping in family enterprise. Excluded are persons with post-graduate qualifications seeking employment in occupations according to subject in which specialised and persons seeking employment as unskilled labourers.

#### **X001 WORKERS WITHOUT OCCUPATIONS: MATRICULATES AND ABOVE**

Workers classified in this Family are those persons seeking employment who have passed High School examination or other higher examinations in general education, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience such as casual work during school holidays or helping in Family enterprise. Included are post graduates and law graduates seeking employment in occupations according to subjects in which specialised.

**X001.10 Matriculates** included under this classification are those persons seeking employment, who have passed High School, Matriculation or equivalent examination, have not received any professional , technical or vocational training and either do

not possess significant work experience or have had only incidental work experience such as casual work during school holidays or helping in family enterprise. Excluded are persons seeking employment in specific occupations.

**X001.15 11<sup>th</sup> Standard Pass** included under this classification are those persons seeking employment, who have passed Higher Secondary (11 years course) or equivalent examination, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience such as casual work during school holidays or helping in family enterprise. Excluded are persons seeking employment in specific occupations.

**X001.20Higher Secondary/  
Intermediates/Senior Secondary/ 10+2  
Pass** included under this classification are those persons seeking employment who have

passed Higher Secondary/ Intermediates/Senior Secondary/ 10+2 examination, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience such as casual work during school holidays or helping in family enterprise. Excluded are those Higher Secondary/ Intermediates/Senior Secondary/ 10+2 pass who are seeking employment in specific occupations.

**X001.30 Graduates, Arts** included under this classification are those persons seeking employment who have graduated in Arts, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience, such as casual work during school holidays or helping in family enterprise. Excluded are those post-Graduates in Arts and Law Graduates who are not seeking employment in occupations according to subject in which specialised, excepting those seeking employment in specific occupations.

**X001.35 Post Graduates, Arts** included under this classification are those post graduates in Arts who are not seeking employment in specific occupations according to subject in which specialised, have not received any professional, technical or vocational training and either do not possess any significant work experience or have had only incidental work experience.

**X001.40 Graduates, Science** included under this classification are those persons seeking employment, who have graduated in Science, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience, such as casual work during school holidays or helping in family enterprise. Excluded are those post-Graduates in Science who are not seeking employment in occupations according to subject in which specialised, excepting those seeking employment in specific occupations.

**X001.45 Post Graduates, Science** included under this classification are those post

graduates in Science who are not seeking employment in specific occupations according to subject in which specialised, have not received any professional, technical or vocational training and either do not possess any significant work experience or have had only incidental work experience.

**X001.50 Graduates, Commerce** included under this classification, are those persons seeking employment, who have graduated in Commerce, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience, such as, casual work during school holidays or helping in family enterprise. Excluded are those post-Graduates in Commerce who are not seeking employment in occupations according to subject in which specialised, but excluded are those seeking employment in specific occupations.

**X001.55 Post Graduates, Commerce** included under this classification are those post graduates in Commerce who are not seeking employment in specific occupations according to subject in which specialised, have not received any professional, technical or vocational training and either do not possess any significant work experience or have had only incidental work experience.

**X001.60 Graduates, Law** included under this classification are those persons seeking employment, who have graduated in Law, have not received any professional, technical or vocational training and do not possess significant work experience or have had only incidental work experience such as casual work during holidays or helping in family enterprise. Excluded are persons seeking employment in specific occupations.

**X001.65 Post Graduates, Law** included under this classification are those post graduates in Law who are not seeking employment in specific occupations according to subject in which specialised, have not received any professional, technical or vocational training and either do not possess any significant work experience, or have had only incidental work experience.

## NATIONAL CLASSIFICATION OF OCCUPATIONS

**X001.90 Graduates, Other** included under this classification are those persons seeking employment, who have passed degree or equivalent diploma/ certificate course in disciplines not strictly falling within any one of the board faculties of Arts, Science or Commerce, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience, such as casual work during school holidays or helping in family enterprise.

**X001.95 Post Graduates, Other** included under this classification are those persons seeking employment who have post graduate degree or equivalent diploma/certificate course in disciplines or specialities not strictly falling within any one of the broad faculties of Arts, Science, Commerce and are not seeking employment in specific occupations according to subject in which specialised.

### **X002 WORKERS WITHOUT OCCUPATIONS: LITERATES**

Workers classified in this Family are those persons seeking employment who are literates (those who can read and write), but have not passed High School or Higher Secondary examination or its equivalent, have not received any professional, technical or vocational training and either do not possess significant work experience, or have had only incidental work experience, such as casual work during school holidays or helping in family enterprise. Excluded are persons seeking employment only in specific occupations or as labourers.

**X002.10 Middle School Standard** included under this classification are those persons seeking employment who have passed eighth Standard, Junior High School/Middle School examination or above, but have not passed High School, Matriculation, Higher Secondary or equivalent examination, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience, such as casual work during school holidays or helping in family enterprise. Excluded are those

persons seeking employment in specific occupations or as labourers.

**X002.90 Literates, others** included under this classification are those persons seeking employment, who are literates (those who can read and write), but have not passed Eighth Standard, Junior High School or Middle School examination, have not received any professional, technical or vocational training and either do not possess significant work experience or have had only incidental work experience, such as, casual work during school holidays or helping in family enterprise. Excluded are those persons seeking employment only in specific occupations or as labourers.

### **X009 WORKERS WITHOUT OCCUPATIONS, OTHER**

Workers classified in this Family are those persons, who have not received any professional, technical or vocational training and do not possess significant work experience and include workers not elsewhere classified.

**X009.90 Workers Without Occupations, other** include those persons who have not received any professional, technical or vocational training and do not possess significant work experience and include workers not elsewhere classified.

### **X1 WORKERS REPORTING OCCUPATIONS UNIDENTIFIABLE OR UNCLASSIFIABLE**

Workers classified in this Sub-division include workers reporting occupations which cannot be identified, workers reporting occupations not sufficiently well described to permit classification in one of the preceding Sub-divisions and workers reporting occupations not classifiable elsewhere because of erroneous reporting or for other reasons.

### **X10 WORKERS REPORTING OCCUPATIONS UNIDENTIFIABLE OR UNCLASSIFIABLE**

Workers classified in this Group are those reporting occupations which can not be identified, those reporting occupations not sufficiently well described to permit

classification in one of the preceding Groups and those reporting occupations not classifiable elsewhere because of erroneous reporting or for other reasons.

**X100 WORKERS REPORTING OCCUPATIONS, UNIDENTIFIABLE OR UNCLASSIFIABLE**

Workers classified in this Family are those, who are reporting occupations that cannot be identified, not sufficiently well described to permit classification or not classifiable elsewhere, because of erroneous reporting or for other reasons.

**X100.10 Workers Reporting Occupations, Unidentifiable or Unclassifiable** included under this classification are those who are reporting occupations, that cannot be identified, not sufficiently well described to permit classification or not classifiable elsewhere because of erroneous reporting or for other reasons.

**X9 WORKERS NOT REPORTING ANY OCCUPATION**

Workers classified in this Sub-Division are those not reporting any information as to their occupation.

**X99 WORKERS NOT REPORTING ANY OCCUPATION**

Workers classified in this Group are those who are not reporting any information about their occupations.

**X999 WORKERS NOT REPORTING ANY OCCUPATION**

Workers classified in this Family are those who are not reporting any information about their occupation.

**X999.10 Workers Not Reporting Any Occupation** included under this classification are those who are not reporting any information about their occupation.
