STATISTICS OF EMPLOYMENT

1249. ADV. A. M. ARIFF:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) whether the Government maintains statistics about employment in private sector, organized and unorganized sectors;**
- (b) if so, the details thereof along with the details of employment provided in organized and unorganized sectors during the last three years and the current year, year-wise, sector-wise and State-wise;**
- (c) if not, the reasons therefor and the efforts made by the Government to collect statistics of employment in organized and unorganized sectors; and**
- (d) the details of the number of people who have gone abroad for employment during the said period, State/UT-wise and year-wise?**

ANSWER

(a) to (c): The quinquennial labour force surveys on employment and unemployment were conducted by National Statistical Office (NSO), Ministry of Statistics and Programme Implementation. The last such survey was conducted during 2011-12. Now, NSO has switched to the annual Periodic Labour Force Survey (PLFS), which was conducted during 2017-18. As per the PLFS, 2017-18 the estimated workforce in organized sector was 19.2% and in unorganised sector was 80.8%. Further, the estimated percentage distribution of usually working persons by broad industry division on usual status (principal status + subsidiary status) basis in the country is given below:

Workforce by Major sectors	2017-18
Primary	44.1%
Secondary	24.8%
Tertiary	31.1%

State/UT-wise estimated worker population ratio which includes organised and unorganised sector for above survey periods ratio for persons of all ages according to usual status (principal status + subsidiary status) basis to the extent available is given at Annexure-I.

(d): The Ministry of External Affairs maintains the data in respect of Emigration Check Required(ECR) passport holders, travelling legally to any of the 18 ECR countries for overseas employment. The 18 countries are namely United Arab Emirates, Kuwait, Afghanistan, Malaysia, Lebanon, Bahrain, Indonesia, Iraq, Jordan, Oman, Qatar, Saudi Arabia, Sudan, Syria, Thailand, Yemen, Libya, South Sudan. The number of people gone abroad during the above period State-wise is placed at Annexure II.
