**(a) to (e): The number of beneficiaries under the Atmanirbhar Bharat Rojgar Yojana (ABRY) in various states including Maharashtra is at Annexure-I.**

**An amount of Rs. 6400 Crore has been allocated during the financial year 2022-23 for the scheme. Since inception of the scheme, till 30.01.2023, an amount of Rs. 8773.00 Crore has been sanctioned and benefits of Rs. 8483.75 Crore have been provided to 60.26 lakhs beneficiaries under the scheme.**

**The details of new employees registered and the funds claimed/actual expenditure incurred under ABRY during the extension period i.e. from 30th June, 2021 to 31st March, 2022 is at Annexure-II.**

**The benefit under ABRY is payable to all the beneficiaries registered under the scheme for a period of 2 years from the date of registration.**
