I am directed to convey the sanction of the President of India for release of **Rs. 3,32,650/- (Rupees Three Lakh Thirty Two Thousand Six Hundred and Fifty only)** as 2nd Installment which is 20% of **total approved amount - Rs 16,63,250/-** as **Grants-in-Aid** to Centurion University of Technology & Management, **Paralakhemundi, Odisha** for establishment of Model Career Centers (MCCs) at the **Centurion University of Technology & Management** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2016-2017.

2- The release of grant-in-aid **Rs. 3,32,650/- (Rupees Three Lakh Thirty Two Thousand Six Hundred and Fifty only)** to Centurion University of Technology & Management is subject to the following terms and conditions:

- I. Centurion University of Technology & Management shall strictly follow the guideline issued by DGE on **10th Dec. 2014** and other orders issued by DGE from time to time.
- II. Centurion University of Technology & Management shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. Centurion University of Technology & Management, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the Centurion University of Technology & Management.
- VI. Centurion University of Technology & Management is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "2230" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .02.101.03.07.31.


