- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred as per scheme guidelines, project outcome and utilization certificate furnished by the Government of Delhi as per GFR.
- VI. The Government of Delhi is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3602" – Labour & Employment for the year 2020-21 (Plan) and Sub heads/ Minor heads
