New Delhi, dated the Jan, 2024

G.S.R. No. - In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Directorate General of Employment and Training (Group 'C' Posts) Recruitment Rules (Amendment), 1983 in so far as they relate to the post of Staff Car Driver, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the Staff Car Driver post in the Directorate General of Employment, Ministry of Labour and Employment, namely:-

1. Short title and commencement. –

- (1) These rules may be called the Directorate General of Employment, Ministry of Labour and Employment, Staff Car Driver (Ordinary Grade) Recruitment Rules, 2024.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. **Number of posts, classification, level in pay matrix. -** The number of said posts, their classification and level in the pay matrix attached thereto, shall be as specified in columns (2) to (4) of the said Schedule.
- 3. **Method of recruitment, age-limit, qualifications etc. –** The method of recruitment, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.

Provided that the upper age limit specified in Column 6 of the Schedule may be relaxed in the case of Scheduled Castes, Scheduled Tribes and other special categories in accordance with the orders of the Government of India issued from time to time.

4. **Disqualifications. –** No person, -

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. **Power to relax. –** Where the Central Government is of the opinion that it is necessary or expedient to do so, it may by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Saving clause. -** Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-Serviceman and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
