Subject: Grant-in-Aid to AISECT, for establishment of Modal Career centers (MCCs) at Indore under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-16 reg

Sir,

I am directed to convey the sanction of the President of India for release of Rs. 5,47,800 (Rupees Five Lakh Forty Seven Thousand Eight Hundred Only), as the 60% of the total approved amount Rs. 9, 13,000/- (Rupees Nine Lakh Thirteen Thousand only), as Grant -in-Aid to MCC AISECT for establishment of Model Career Center (MCC) at Indore, Madhya Pradesh under Mission Mode Project for Employment Exchanges (National Career Service Project) during 2015-2016.

2- The release of grant-in-aid of Rs. 5,47,800 (Rupees Five Lakh Forty Seven Thousand Eight Hundred only), to AISECT Indore is subject to the following terms and conditions.

- I. The MCC AISECT, Indore shall strictly follow the guidelines issued vide by DGET on 10th Dec.2014 and additional guidelines for other than Central/State Governments Institutions issued on 05.03.2015.
- II. The MCC AISECT, Indore shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, related to the MCC in accordance with the Governments norms.
- III. The MCC AISECT Indore shall abide by the instructions contained in the Scheme and Guidelines and orders issued from DGET time to time by the DGET.
- IV. The MCC, AISECT, Indore shall strictly follow all the provisions and rules contain in chapter 09 under "GIA and Loans" of GFR-2005.
- V. The MCC, AISECT, Indore is requested to utilize the said amount as first installment.
- VI. Utilization certificate issued to DGET In form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VII. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the MCC AISECT Indore.
- VIII. The MCC, AISECT, Indore shall utilize the above Grants-in-Aid for Non Recurring purposes only.
- IX. Noted at serial No. 10 in Register of Grants.
- X. The above amount as Grants-in-Aid shall be spent in the Financial Year 2015-16 and in any condition not later than March 31, 2016.
- XI. The Agreement between DGE&T and the AISECT, Indore has been signed.
- XII. This sanction issues with the approval of the Secretary, Ministry of Labour and Employment in consultation with the Integrated Finance Division of the Ministry.
