Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 9,57,300/- (Rupees Niné Lakh Fifty Seven Thousand and Three Hundred only)**, which is 2<sup>nd</sup> part payment of the 60% of total approved amount - **Rs. 31,91,000 /-** as **Grants --in-Aid to State Government of Andhra Pradesh**, for establishment of Model Career Centers (MCCs) at the **Anantapur Employment Exchanges** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2016-2017.

2- The release of grant-in-aid **Rs. 9,57,300/- (Rupees Nine Lakh Fifty Seven Thousand and Three Hundred only)** to **State Government of Andhra Pradesh** is subject to the following terms and conditions:

- I. **State Government of Andhra Pradesh** shall strictly follow the guideline issued vide by DGET on **10<sup>th</sup> Dec. 2014** and other orders issued by DGE&T from time to time.
- II. **State Government of Andhra Pradesh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Andhra Pradesh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Andhra Pradesh.
- VI. The State Government of Andhra Pradesh is requested to utilize the said amount as 2<sup>nd</sup> part payment of first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2016-17 as mentioned below:


