Subject: Grants –in-Aid to **Government of Assam**, for establishment of Model Career Centers (MCCs) at the Employment Exchange **Haflong**, under **National Career Service Project (Mission Mode Project for Employment Exchanges) during 2019-2020 reg.**

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 7,97,000/- (Rupees Seven Lakh and Ninety Seven Thousand only)** as 2<sup>nd</sup> Installment which is 20% of **total approved amount – Rs 39,85,000/- as Grants –in-Aid** to Government of Assam, for establishment of Model Career Centers (MCCs) at the **Employment Exchange Haflong** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2. The release of Grants-in-aid **Rs. 7,97,000/- (Rupees Seven Lakh and Ninety Seven Thousand only)** to **Government of Assam** is subject to the following terms and conditions:

- I. **Government of Assam** shall strictly follow the guideline issued by DGE on **10<sup>th</sup>Dec.2014** and other orders issued by DGE from time to time.
- II. **Government of Assam shall** maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of Assam shall** abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred as per scheme guidelines, project outcome and utilization certificate furnished by the Government of Assam as per GFR.
- VI. The Government of Assam is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2019-2020 (Plan) and Sub heads/ Minor heads



The Government of Assam may kindly transfer the amount to Office I/C, District Employment officer/ Deputy Director, Employment Exchange, Haflong.
