Subject: Grants –in-Aid to **State Government of Chhattisgarh**, for establishment of Model Career Centers (MCCs) at the **Durg Employment Exchange** under **National Career Service Project (Mission Mode Project for Employment Exchanges)** during 2016-2017 reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 14,04,600/- (Rupees Fourteen Lakh Four Thousand and Six Hundred only)** as 2<sup>nd</sup> Installment which is 20% of total approved amount – **Rs 49,23,000 /-** and balance amount of 60% of the first installment, as **Grants –in-Aid** to State Government of Chhattisgarh, for establishment of Model Career Centers (MCCs) at the **Durg Employment Exchanges** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2016-2017.

2- The release of grants-in-aid **Rs. 14,04,600/- (Rupees Fourteen Lakh Four Thousand and Six Hundred only)** to **State Government of Chhattisgarh** is subject to the following terms and conditions:

- I. **State Government of Chhattisgarh** shall strictly follow the guideline issued by DGE on **10<sup>th</sup> Dec. 2014** and other orders issued by DGE from time to time.
- II. **State Government of Chhattisgarh** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Chhattisgarh**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Chhattisgarh.
- VI. The State Government of Chhattisgarh is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .04.796.52.01.31.



Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Chhattisgarh, may kindly transfer the amount to **District Employment Officer, Employment Exchanges, Durg, Chhattisgarh.**
