CII shall strictly follow the guideline issued by DGE on 10thDec.2014 and other orders issued by DGE from time to time.

- I. CII shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.


- II. CII, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- III. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- IV. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the CII.

The grants – in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) – B/68 dated 25th November 1969. The Section Officer (Cash Section)/Drawing and Disbursing officer, DGE, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para – 1 above for **Rs. 22,46,820 (Rs. Twenty Two Lakh Forty Six Thousand Eight Hundred and Twenty)** and remit the same to CII for establishment of Model Career Centre at Gurgaon, Chennai and Mumbai through E-remittance under intimation to DGE, New Delhi as per details given below.
