Sir,

I am directed to convey the sanction of the President of India for release of Rs. 19,97,880/- (Rupees Nineteen Lakh Ninety Seven Thousand Eight Hundred Eighty only), which is the 60% of total approved amount - Rs. 33,29,800/- as Grant –in-Aid to State Government of Tamilnadu, for establishment of Model Career Centers (MCCs) at the Coimbatore Employment Exchanges under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2015-2016.

2- The release of grant-in-aid Rs.19,97,880/- (Rupees Nineteen Lakh Ninety Seven Thousand Eight Hundred Eighty only) to State Government of Tamilnadu is subject to the following terms and conditions.

- I. State Government of Tamilnadu shall strictly follow the guideline issued vide by DGET on 10<sup>th</sup> Dec. 2014 and other orders issued by DGE&T from time to time.
- II. State Government of Tamilnadu shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. State Government of Tamilnadu, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. ~~The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Tamilnadu.~~
- VI. The State Government of Tamilnadu is requested to utilize the said amount as first installment
- VII. MOU between DGE&T and the State Government of Tamilnadu will need to be signed.

The expenditure involved is debatable to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The amount of Rs.19,97,880/- (Rupees Nineteen Lakh Ninety Seven Thousand Eight Hundred Eighty only) may be transferred to State Government of Tamilnadu through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Tamilnadu, may kindly transfer the amount to District Employment Officer, Employment Exchanges, Coimbatore, Tamilnadu.
