Subject: Grants –in-Aid to **Government of Tripura**, for establishment of Model Career Centers (MCCs) at the Employment Exchange **Dharamnagar**, under **National Career Service Project (Mission Mode Project for Employment Exchanges) during 2019-2020** reg.

Sir,

I am directed to convey the sanction of the President of India for release of **Rs.3,46,380/- (Rupees Three Lakh Forty Six Thousand Three Hundred and Eighty only)** as 2nd Installment which is 20% of total approved amount – **Rs 17,31,900/-** as Grants –in-Aid to Government of Tripura, for establishment of Model Career Centers (MCCs) at the **Employment Exchange Dharamnagar** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2019-2020.

2. The release of Grants-in-aid **Rs.3,46,380/- (Rupees Three Lakh Forty Six Thousand Three Hundred and Eighty only)** to **Government of Tripura** is subject to the following terms and conditions:

- I. **Government of Tripura** shall strictly follow the guideline issued by DGE on **10thDec.2014** and other orders issued by DGE from time to time.
- II. **Government of Tripura** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **Government of Tripura** shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGE in form GFR 12C in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released on the basis of actual expenditure incurred as per scheme guidelines, project outcome and utilization certificate furnished by the Government of Tripura as per GFR.
- VI. The Government of Tripura is requested to utilize the said amount as second installment.

The expenditure involved is debitable to Major Head "3601" – Labour & Employment for the year 2019-2020 (Plan) and Sub heads/ Minor heads 0.6.101.34.01.31.


The amount of **Rs.3,46,380/- (Rupees Three Lakh Forty Six Thousand Three Hundred and Eighty only)** may be transferred to **Government of Tripura** through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The

Government of Tripura may kindly transfer the amount to Office I/C, District Employment officer/ Deputy Director, Employment Exchange, Dharamnagar.
