Subject: Grants –in-Aid to Devi Ahilya University, Indore, for establishment of Model Career Centers (MCCs) at the Devi Ahilya University, Indore under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017 reg.

Sir,

I am directed to convey the sanction of the President of India for release of Rs. 9,30,120/- (Rupees Nine Lakh Thirty Thousand One Hundred and Twenty only), which is 60% of total approved amount - Rs. 15,50,200/- as Grants –in-Aid to Devi Ahilya University, Indore , for establishment of Model Career Centers (MCCs) at the Devi Ahilya University, Indore under National Career Service Project (Mission Mode Project for Employment Exchanges) during 2016-2017.

2- The release of grant-in-aid of Rs. 9,30,120/- (Rupees Nine Lakh Thirty Thousand One Hundred and Twenty only) to Devi Ahilya University, Indore is subject to the following terms and conditions.

- I. The MCC Devi Ahilya University, Indore shall strictly follow the guidelines issued by DGE on 10thDec.2014 and additional guidelines for other than Central/State Governments Institutions issued on 05.03.2015.
- II. The MCC Devi Ahilya University, Indore shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, related to the MCC in accordance with the Governments norms.
- III. The MCC Devi Ahilya University, Indore shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time by the DGE.
- IV. The MCC, Devi Ahilya University, Indore shall strictly follow all the provisions and rules contain in chapter 09 under "GIA and Loans" of GFR-2005.
- V. The MCC, Devi Ahilya University, Indore is requested to utilize the said amount as first installment.
- VI. Utilization certificate issued to DGE in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- VII. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the MCC Devi Ahilya University, Indore.
- VIII. The MCC, Devi Ahilya University, Indore shall utilize the above Grants-in-Aid for Non Recurring purposes only.
- IX. Noted at serial No. 15 in Register of Grants.
- X. The Agreement between DGE and the Devi Ahilya University, Indore has been signed.
- XI. This sanction issues with the approval of the Secretary, Ministry of Labour and Employment in consultation with the Integrated Finance Division of the Ministry.

The expenditure involved is debit to Major Head "2230" – Labour & Employment for the year 2016-17 (Plan) and Sub heads/ Minor heads .02.101.03.07.31.

The grants – in aid will be released in accordance with procedure laid down in the Ministry of Finance Department of Economic Affairs Office Memorandum No. 10(48) – B/68 dated 25th November 1969. The Section Officer (Cash Section)/Drawing and Disbursing officer, DGE, Ministry of Labour & Employment, New Delhi will draw the amount sanctioned vide para – 1 above for Rs. Rs. 9,30,120/- (Rupees Nine Lakh Thirty Thousand One Hundred and Twenty only) and remit the same to Devi Ahilya University, Indore (UEIGB) through E-remittance under intimation to DGE, New Delhi as per details.
