Sir,

I am directed to convey the sanction of the President of India for release of **Rs. 5,19,570/- (Rupees Five Lakh Nineteen Thousand Five Hundred and Seventy only)**, which is part payment of the 60% of total approved amount - **Rs. 17,31,900 /-** as **Grants -in-Aid** to State Government of Tripura, for establishment of Model Career Centers (MCCs) at the **Dharmanagar Employment Exchanges** under National Career Service Project (**Mission Mode Project for Employment Exchanges**) during 2015-2016.

2- The release of grant-in-aid **Rs. 5,19,570/- (Rupees Five Lakh Nineteen Thousand Five Hundred and Seventy only)** to **State Government of Tripura** is subject to the following terms and conditions:

- I. **State Government of Tripura** shall strictly follow the guideline issued vide by DGET on 10<sup>th</sup> Dec. 2014 and other orders issued by DGE&T from time to time.
- II. **State Government of Tripura** shall maintain proper accounts for purchases of IT Infrastructure, Furniture and Fixtures, Minor Civil Works and other expenditure etc, in accordance with the Governments norms.
- III. **State Government of Tripura**, shall abide by the instructions contained in the Scheme and Guidelines and orders issued from time to time.
- IV. Utilization certificate issued to DGET in form GFR 19A in duplicate and component wise, year wise expenditure statement may be furnished immediately after utilization.
- V. The next installment of the fund would be released as per provision of GFR on the basis of actual expenditure incurred and utilization certificate furnished by the State Government of Tripura.
- VI. The State Government of Tripura is requested to utilize the said amount as first installment.

The expenditure involved is debitable to Major Head/Sub Head (plan) for the year 2015-16 as mentioned below:



The amount of Rs. 5,19,570/- (Rupees Five Lakh Nineteen Thousand Five Hundred and Seventy only) may be transferred to State Government of Tripura through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide OM No. F-II (45/76/SC) dated 22-02-1977. The Government of Tripura may kindly transfer the amount to District Employment Officer, Employment Exchanges, Dharmanagar, Tripura.




